Completion of SPP Shortfall Placement

Highlights

- Share Purchase Plan (SPP) shortfall placed to raise \$1,478,400
- Total of \$3,000,000 raised under SPP and shortfall placement
- Funds to be used, together with the placement proceeds to advance the Leigh Creek Pre-Commercial Demonstration, completion of feasibility study on small scale development options and general working capital.

Summary

South Australian energy company, Leigh Creek Energy Limited (ASX: LCK) ("LCK" or "the Company") advises that following strong support from shareholders during the recent Share Purchase Plan ("SPP") which raised \$1.52 million, it has placed the shortfall from the SPP of \$1.48m to institutional and sophisticated investors who are primarily existing shareholders of the Company and has issued the shares today. CCZ Equities was Lead Manager to the SPP shortfall placement.

LCK raised \$1,521,600 through its SPP with the allotment of 9,510,000 shares to existing shareholders. The balance of the total allotment of 18,750,000 shares will be to investors who participated in the shortfall placement.

The final tranche of the \$13.24 million capital raising (before fees) is the placement of 27,126,447 shares to China New Energy Group Limited (CNE) at 16 cents per share to raise \$4.34m, which is subject to shareholder approval at a General Meeting of shareholders on 22 August 2018. Upon approval and placement, CNE return to its percentage shareholding pre-capital raising of 32.78%.

Managing Director Phil Staveley stated: "Being able to place these shares so soon after the SPP to primarily existing shareholders represents a strong result, and again, we express our gratitude to a loyal shareholder base which supports the Company in such a significant manner. I have previously stated that the SPP precedes a series of significant de-risking events for LCK, not the least of which is first gas flow from PCD operations, anticipated in Quarter 3, 2018, and the subsequent upgrading of a portion of LCK's gas resource to a reserve, targeted for Quarter 4, 2018."
